Decision: Members discussed the proposal minutely considering every aspect and reasons behind the recommendations made by the departments and approved it unanimously.

Proposal 4: Approval to the number of Academic and Administrative positions

Decision: Shri Priyesh Pagariya presented the proposal to approve the number of positions in Academic and Administrative departments as per the requirements in various departments according to number of students in each of them. This proposal was presented to meet the requisite student-teacher ratio in each department. Similarly due to growing size of the University, requirement of Administrative staff is also rising.
